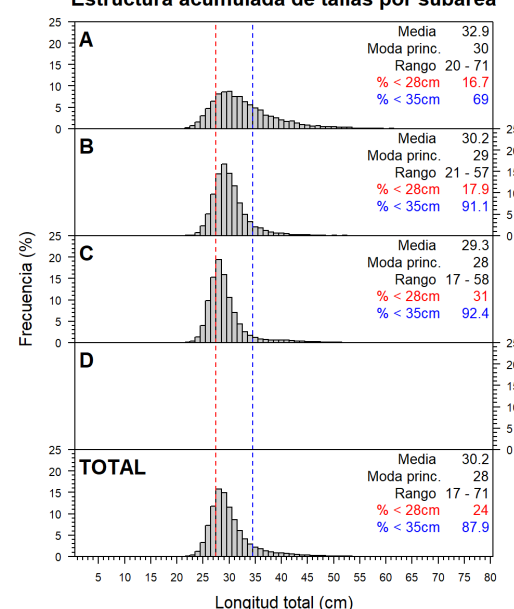
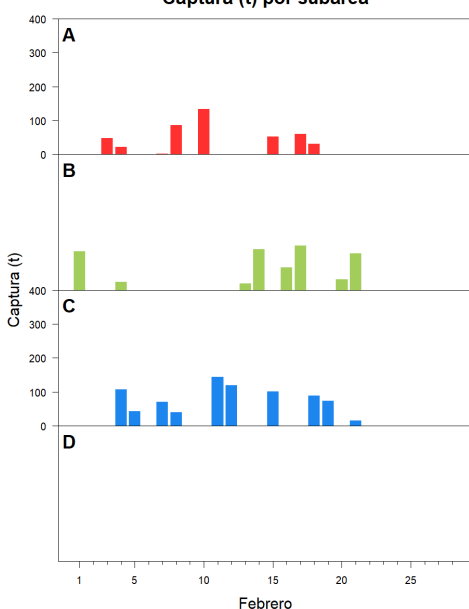
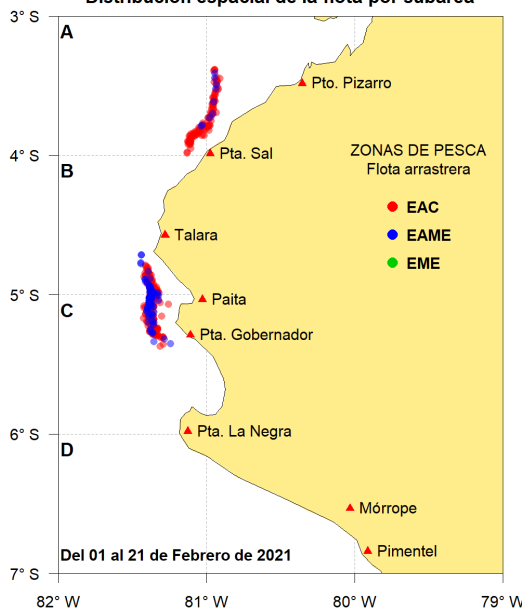

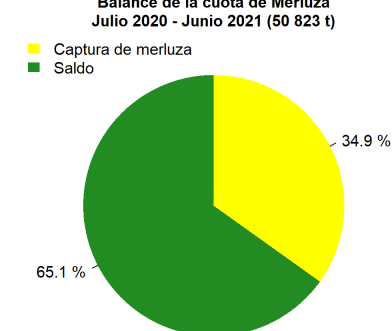
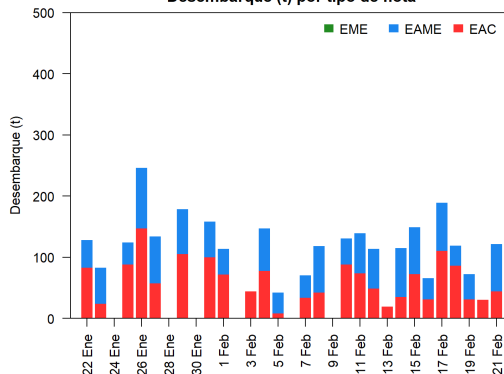
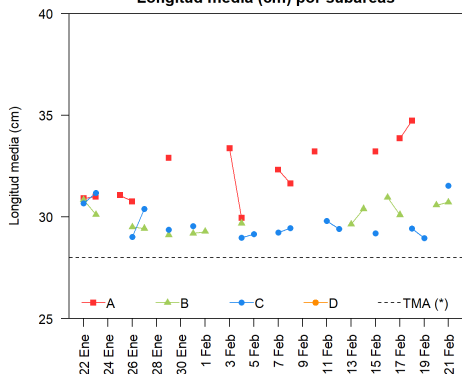
Estructura acumulada de tallas por subárea
