



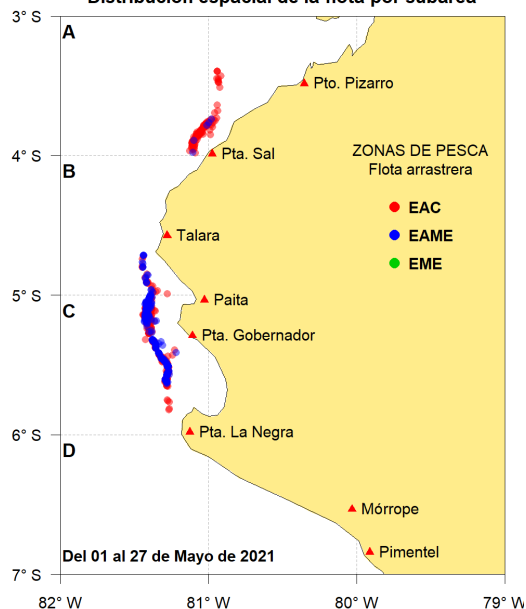

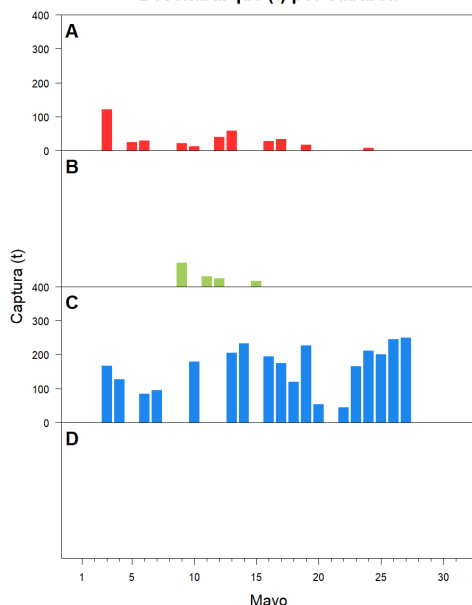

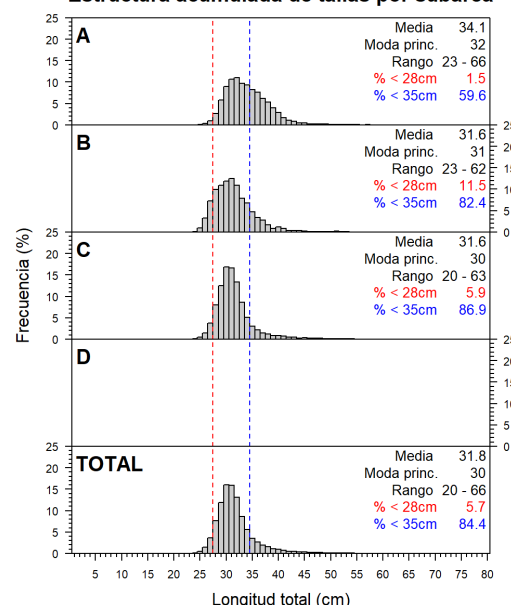
Distribución espacial de la flota por subárea



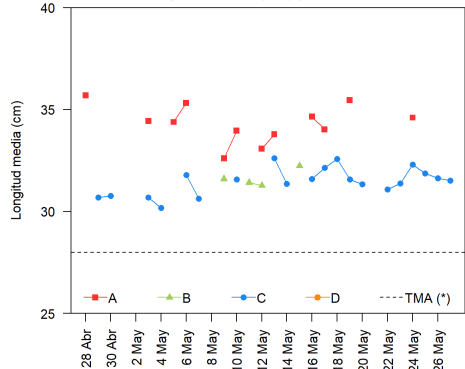
Desembarque (t) por subárea



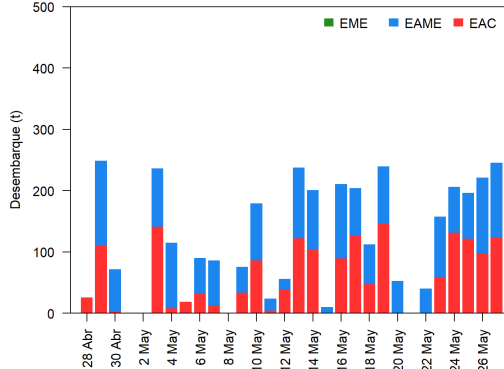
Estructura acumulada de tallas por subárea



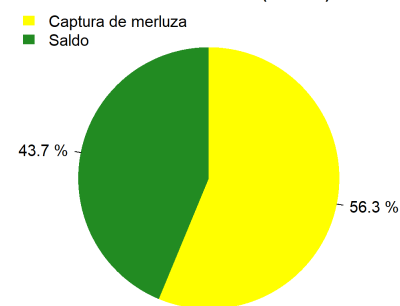
Longitud media (cm) por subáreas
